### **Overview and Background:**

This item is provided for the purpose of electing a Mayor Pro Tem from among the Council to serve the remainder of an unexpired term, expiring May 2021.

Pursuant to Section 3.04 (5) of the City of Fate Home Rule Charter, the Mayor Pro Tem shall act as Mayor during the disability or absence of the Mayor and in this capacity, shall have all the rights conferred upon the Mayor and shall still be entitled to vote as a Council Member.

On January 4, 2021 David Billings was selected to hold the position of Mayor Pro Tem with a term expiring May 2021. David Billings resigned from the City Council when he filed as a candidate for Mayor in the May 1, 2021 Election, thus creating a vacancy in the position of Mayor Pro Tem.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FATE, TEXAS, ELECTING A MAYOR PRO TEM FOR THE CITY OF FATE FOR THE REMAINDER OF AN UNEXPIRED TERM EXPIRING MAY 2021; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS,** the City Charter of the City of Fate, Texas, in Section 3.04, provides for the City Council to select from among themselves a Council member to serve as Mayor Pro Tem of the City of Fate; and,

**WHEREAS,** on January 4, 2021 David Billings was selected to hold the position of Mayor Pro Tem with a term expiring May 2021; and

**WHEREAS,** David Billings resigned from the City Council when he filed as a candidate for Mayor in the May 1, 2021 Election, thus creating a vacancy in the position of Mayor Pro Tem; and

**WHEREAS,** the City Council members of the City of Fate voted and selected \_\_\_\_\_ to hold the position of Mayor Pro Tem for the remainder of the unexpired term expiring May 2021.
